- cashier order(s) or (if the Vendor consents) cheque(s) (the number of cashier order(s) or cheque(s) shall be equal to the number of specified residential property(ies) which the person is interested in purchasing), each cashier order or cheque shall be in the sum of HK\$100,000 and made payable to 'GRANDALL ZIMMERN LAW FIRM'.

There is no restriction on the number of specified residential properties that that person may purchase.

If for any reason the Purchaser fails to enter into the preliminary agreement(s) for sale and purchase for the selected specified residential property(ies), the Vendor shall have no obligation to enter into any preliminary agreement for sale and purchase in respect of the selected specified residential property(ies) and the Purchaser will be deemed to have given up the right to select and purchase any specified residential property(ies).

After the signing of the preliminary agreement(s) for sale and purchase, the cashier order(s) or cheque(s) submitted by the Purchaser will be used to settle part of the preliminary deposit payable by the Purchaser pursuant to the preliminary agreement for sale and purchase. The Purchaser shall on spot pay the balance of the preliminary deposit by cashier order or cheque. Failure to pay the balance of the preliminary deposit by the Purchaser in respect of any preliminary agreement for sale and purchase shall be deemed as that Purchaser failing to enter into preliminary agreement(s) for sale and purchase for all the selected specified residential property(ies), in which event the Vendor shall have

no obligation to enter into any preliminary agreement for sale and purchase with that Purchaser and the Purchaser will be deemed to have given up the right to select and purchase any specified residential property(ies).
